I wish to enroll my child \_\_\_\_\_, in Munchkinland & More Pre-school for the academic year 2020-2021 for the price of \_\_\_\_\_/month, I understand and agree to abide by the following school policies:

1. Enrollment in the Preschool Program; Term – Parents or Guardians agree that Student shall be enrolled in the Preschool Program for the school year 2020, which begins on Tuesday, September 8<sup>th</sup>, 2020 and ends on Thursday, May 13<sup>th</sup>, 2021.

2. Non-refundable Fees and Deposits. Parent or Guardians agree to pay to Munchkinland and More the following non-refundable fees and deposits: If already paid this will be marked.

a. Registration Fee: For new and re-enrolling students, Parents or Guardians agree to pay a \$40 non-refundable annual registration fee. Payment of the Registration Fee is due at the time the registration form is returned.

3. Tuition Payment Options: Initial by which one you shall choose. Checks should be made payable to Munchkinland and More.

a. Monthly Payments: Due the 1<sup>st</sup> of each month with a grace period till the 7<sup>th</sup>. With a \$35.00 late fee charged if paid after the 7<sup>th</sup> of the month.

b. Semi-Annual: Two separate payments for the Months of (September-December) (January-May). The first payment is due on September 1<sup>st</sup> and then the second is due January 1<sup>st</sup> with a grace period till the 7<sup>th</sup> of the month before the late fee is applied.

c. Annual: One payment for your child's tuition for the school year of 2020-2021. This payment is due September 1<sup>st</sup>, 2020 with the grace period till the 7<sup>th</sup> of the month.

4. Early Withdrawal or Munchkinland and More's Termination.

a. Return of Fees and Deposits. Parents or Guardians agree and understand that the Registration Fee is non-refundable.

b. Tuition Payments: Parents or Guardians agree and understand: Early withdrawal of the Student from Munchkinland and More's programs requires written notification with a 30 day advance written notice and will need to pay the next two months following written notice. Failure to give written notification will result being charged for three months following.

c. Termination: Munchkinland and More reserves the right to terminate this Enrollment Contract and disenroll Students from Munchkinland and More programs for any reason. Parents or Guardians agree and understand that termination of this Enrollment Contract and disenrollment of Student from Munchkinland and More's programs does not change the refund provisions set forth in the paragraph 4 of this Enrollment Contract.

d. Illnesses and Vacations: Munchkinland and More does not give refunds for days Student is absent due to illnesses, vacations or other personal reasons.

c. Please see the School Calendar for a schedule of days school is closed. We will be closed the same days as USD 257.

d. Any returned checks or declined charges will require a \$30.00 reprocessing fee.

e. Munchkinland and More reserved the right to adopt/amend rules and regulations as deemed necessary. The Student and the Parents or Guardians shall comply fully with the rules and regulations as stated or amended in the Student/Parent Handbook.

f. All students will be accepted on a conditional basis. Parents or Guardians may be asked to withdraw Student if Munchkinland and More determines, in its sole discretion, that the program is not meeting Student's needs or that the Student's presence is having an adverse effect on the program.
